**Guidelines for Incorporating NEX results into consolidated Income Statement:**

Trading revenues from Markets businesses (EBS and Brokertec) to be included in 'Clearing and transaction fees'

Revenues from Market data sales included in 'Market data and information services'

Remaining revenues from Optimization business to be split between 'Clearing and transaction fees' and 'Other', based upon nature of the revenue

Expenses mapped into expense lines based upon nature of expense
